B. Nutrient Mass Balance tests to see what nutrients are in the lake. It would be a 2 year intense water sampling at a cost of \$20.000.00 - \$120,000.00.

C. Stewardship Active 2 year commitment. Hire summer student re: clean, education and shoreline. This would produce data for future decisions.

Sherry Jimmy asked the Jackfish Lake Watershed Association to join communities around the lake to do a lake development study on Jackfish Lake. The cost would be \$100,000.00.

Penny Duncan asked that Jackfish Watershed take the lead on the work started by the Stewards of Jackfish Lake.
