The undersigned has the honour to report that:


- 1. Section 10 of The Watershed Associations Act provides as follows:

The Lieutenant Governor in Council may at any time, if deemed advisable for the purpose of ensuring that the several agencies constituting the association will be equitably represented on the board, by order increase or reduce the number of persons to be appointed by any specified agency, and where such an order is made the agency affected shall take such action as may be necessary to increase or reduce its representation on the board, as the case may require."
